OFFICIAL RULES

1. NO ENTRY FEE, PAYMENT OR PURCHASE NECESSARY.

The Contest: From 8/11-8/15/08 WBNX and the Cleveland National Air Show will promote by means of the wbnx.com website, on-air promotions and the Cleveland National Air Show website, the opportunity to **log on & win** tickets to the Cleveland National Air Show and one (1) Grand Prize as detailed below.

2. HOW TO ENTER:

To enter the “WBNX Cleveland Air Show Contest” online, you must have internet access. Access the WBNX website at www.wbnx.com and follow all instructions to locate the contest page, and complete the online entry form. All required fields must be completed and entry forms must be submitted including the correct “key word”. The “keyword” will be revealed in a pop up graphic during “Everybody Loves Raymond”, M-F 7-8pm 8/11-8/15/08 on WBNX. This pop-up will air twice per day during the 7pm-8pm time period. **One Grand Prize Winner will win four (4) tickets to the Cleveland National Air Show held at Burke Lakefront Airport August 30-September 1, 2008 and an airplane ride with a Cleveland National Air Show Pilot! Nine runner-up winners will win four (4) tickets to the Cleveland National Air Show for a total of 10 winners for the entire promotion.**

Limit one (1) entry per person, per day. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents will void all entries by that entrant. All mass entries, reproductions, duplicate entries and entries without the complete required information will void all entries by that entrant.

3. ELIGIBILITY: Some restrictions may apply. Entrants must be legal residents of the United States and be at least 18 years of age as of the date of entry. Proof of age and legal U.S. residency may be required. Entrants must reside in the WBNX Northeast Ohio viewing area.

One (1) Grand Prize winner will receive: One (1) ride with an Air Show Pilot in an aircraft to be determined by the Cleveland Air Show to take place on or around Thursday, August 28, 2008, (Approximate value \$400); and four (4) tickets to the Cleveland National Air Show held at Burke Lakefront Airport August 30-September 1, 2008. (Ticket retail value \$21.00 each)
