The secret word of the night will be revealed sometime between 7PM-7:30PM on WBNX-TV during the show “Last Man Standing” the week of 2/6/17-2/10/17.

All required fields on the online entry form must be completed and entry forms must be submitted **including the correct keyword or secret word of the night.**
