

“WBNX-TV / Portage County Randolph Fair Kids Day Event”
OFFICIAL RULES – For On-Site Promotion
8/25/2022

How to Participate:

WBNX-TV Event Crew will be on-site at the Portage County Randolph Fair Kids Day Event on 8/25/2022 during WBNX-TV booth operating hours 10am-12pm at the Portage County Randolph Fair, located at Portage County Fairgrounds, 4215 Fairground Rd, Randolph. Participants must be present at the WBNX-TV booth during hours of operation noted to participate in the activities.

WBNX Booth: Kids Day Scavenger Hunt from 10am-12pm. The first 300 kids under 12 years old to come to the WBNX-TV table who are participating in the fair scavenger hunt and have a scavenger hunt sheet, can receive a free Pictionary Mini Art Set (One per person, while supplies last, subject to availability). Only for those participating and present.

PRIZE DRAWING:

WBNX Booth: While at the event, attendees can enter for their chance to win one *National Geographic Kids* book prize pack which includes three different books by filling out the entry form provided at the WBNX booth and placing it in the entry box.
